COMMON THEMES, COMMON SCHEMES

There is more than one way to embezzle money and many perpetrators will use more than one method. Whether it is the simplest approach or the most complex, understanding how these schemes work helps in prevention.

FUNDS THEFT

Perpetrators take cash or bank deposits and transfer the funds to an account they control.

CHECK FRAUD

Checks are altered or forged to be made payable to the perpetrator.

DRIVER'S LICENSE/IDENTITY THEFT

Identity theft occurs when someone assumes your identity to perform a fraud or other criminal act.

CREDIT CARD FRAUD

Company credit cards are used for personal purchases, or unauthorized credit cards are issued.

FINANCIAL STATEMENT FRAUD

Financial statement fraud is the manipulation of the information used to prepare the financial statements

released to the public and financial institutions. Five basic types of financial statement fraud exist:

- fictitious sales
- improper expense recognition
- incorrect asset valuation
- hidden liabilities
- unsuitable disclosures

PAYROLL FRAUD

The perpetrator pays fictitious or terminated employees and diverts the funds to personal accounts.

MERCHANDISE/ PROPERTY THEFT

The perpetrator steals property or merchandise belonging to the company. This may be the most underreported category of employee theft.

PHISHING SCHEMES

Phishing is a type of social engineering attack often used to steal user data, including login credentials and credit card numbers.

PONZI SCHEMES

"Ponzi" schemes promise high financial returns or dividends not available through traditional investments. Instead of investing the funds of victims, however, the con artist pays "dividends" to initial investors using the funds of subsequent investors.

EXPENSE FRAUD

Expenses that are reimbursed by the company are fabricated or inflated.

VENDOR INVOICING & FALSE BILLING

Invoices from vendors are fabricated, inflated, or fictitious vendor companies are invented.

MONEY LAUNDERING

Money laundering is the process by which criminals conceal or disguise their proceeds and make them appear to have come from legitimate sources.

MISBRANDING

Misbranding occurs when any consumer product is labeled in a false or misleading way by omitting information, providing false content or quantity information, or concealing information by minimizing placement, removing a label, or misleading with the container shape and size.

ALTERATION OF A DRUG

This fraud occurs if a drug is prepared in unsanitary conditions, contains rotten substances, contains poisonous substances, or is prepared in any way that will cause injury or death.
